Reuben Stone (1755-1849) was placed on the pension roll, 1829, for service as private in Capt. Henry Hampton's company, Lieut.-Col. William Henderson's 6th South Carolina regiment. He was born in Fauquier County, Va; died in Madison County, Ala.
